

Communications

Communicate with TPs regularly

Ensure that the information is relevant

Agree a communication strategy with TPs and signpost TPs to active surveys

Agree on a central location for information to be shared to help reduce email traffic

Surveys

Surveys to be designed to capture:

The roles and the responsibilities of the TPs

Number of TPs

Differences in the roles

How the role has changed and the rate of change

Aspirations of the TPs

Identify support required for the role of the TP

Surveys to be short and feedback to the TPs as soon as possible

Framework/Job Description

Review previous frameworks

Analyse survey feedback from TPs to develop framework

Ensure that framework is approved and has appropriate governance

Levels of expertise

Education resources for TPs to be included

Identify gaps, including knowledge, education resource, support etc and highlight accordingly

Posters/Presentations

Develop posters, presentations that can be used locally, regionally, nationally and Internationally


