HTC Key Priorities - themes

- Maintaining PBM
- Electronic tracking systems funding and implementation
- Training to implement new systems and decrease incidents

HTC Audits in Progress / Completed - themes

- National audits completed awaiting reports to action.
- Bedside audits
- Authorisation/paperwork audits
- Some trusts mentioned lack of additional audits performed due to staff capacity. (Linked to electronic tracking roll out.)

QS138 Quality Insights Audit Tool

• Majority of trusts did have staff that have signed up

Pre-Op Anaemia CQUIN

- Difficult to manage in a paediatric setting
- On Trust audit plan. Pre-op anaemia SOP updated to include
- IDA service
- Lead by Pre-op team
- Via expansion plans
- Pre-op anaemia pathway implemented
- IV iron service for patients prior to surgery and those with heart failure requiring treatment was active prior to CQUIN. Fortunately, we continue to see and treat patients, and the loss of CQUIN has not impacted this.

6. BBTS Feedback

7. Patient Representation

8. AOB

Change in Title of HTC's

It was suggested the change in title of "HTCs" to "PBM Committee" or something similar as needs to be recognised / get buy in from higher levels. More support needed from HTC Chair's. HTC does not reflect the remit of the wider PBM priorities.

Consent for Transfusion

To be part of the documented process within Trusts.

Action: Craig Carroll to raise above points at next NBTC Meeting. (CC)

Core Mandatory Training

Discussion regarding agreement for core mandatory training for some groups of rotating medical staff, to reduce the burden on TPs posed by attending induction frequently through the year. Proposal is to begin with trainees in Anaesthesia within the Mersey rotation, as this has already been discussed and agreed in principle by all stakeholders at the most recent training meeting. For this to be successful, all Trusts receiving doctors on that rotation would need to agree a set standard of mandatory training that would be maintained. This would then allow local induction processes to be limited to local processes only, rather than more lengthy sessions.
