RTC Update

Objectives:

- O positive in bleeding men support will continue to be provided to hospitals on a oneto-one basis, and the RTT will check in with progress.
- Survey for maternal anaemia management practice is completed, it will be presented to the SW regional perinatal leadership team to raise awareness.
- Tranexamic acid was suggested as next regional focus may be re-considered due to national focus for Amber alert open to suggestions

Transfusion Survey:

• Deadline extended to the end of February for a few trusts that have not completed the survey. Analysis to be completed by the end of April

Education:

- The next topic selected for the NBTC education programme covers transfusion practice in medicine. Planned date 7th or 14th June 2023, virtual event, MS Teams is only viable platform due to costs.
- The working groups including the PBMG and the TLM continue to support education pertinent to their members.
- The regional BMS education programme, designed to support the national BMSEDG, by covering core topics continues to roll out

- Use the new question on the hospital report for the RTC as an opportunity to raise any issues, questions or queries to the region or to escalate issues to NBTC if needed.
- Continue to provide feedback to NHSBT to ensure accurate forecasting
- Upward trend in demand for O Neg steps in place to increase donor base






