7. Quality Improvement Projects / Alignment of Policies

Questions included on the July HTC report forms

- 'Historically NHSBT representatives have been invited to your HTC meetings. What benefit do you see in that representation?' most Trusts noted that they felt attendance would be beneficial but did not state what that would look like. As the PBMP can not attend all HTC meetings the group felt that we should produce a summary on stock management / customer related issues / benchmarking of wastage to other hospitals
 - **Action**: Produce a forms survey to HTC chars outlining that although attendance at HTC meetings would beneficial, PBMPs do not have the capacity to attend every meeting. Requests for input into projects would be on a request basis. Ask what they would like from NHSBT and in what format.
- What is the best and most effective way to get patient stories into training?
 Looking to use patient stories in medical education meetings, incident reviews and regional newsletter. Patients can aid reviewing patient information leaflets and patient specific pathways.
 - **Action:** Request RTT training rep develop a patient working group along with a TP lead, to look at what is the best and most effective way to get patient stories into training.
- Transfusion thresholds in fractured neck of femur. Variation noted in the thresholds applied pre-operatively on the basis of the Associate of Anaesthetists guidelines.
 This differs from NICE/BSH thresholds. How wide spread is the use of this? Are there trust specific policies in place? Most trusts did not have a specific policy and were following NICE, but several have a threshold of 90-100.
 - **Action:** Summary embedded in RTC meeting minutes. Trusts to consider is this informed consent, is this in the patient's best interest or to ambulate earlier and prevent bed days?
