Transfusion 2024 Update

A collaboration between NHS Blood and Transplant, the National Blood Transfusion Committee and key stakeholders led to the development of the [Transfusion 2024 strategy](#). The plan outlined key priorities for both clinical and laboratory transfusion practice, identifying the need for a system-wide approach to improve transfusion care across the NHS. A dedicated team of subject matter experts, led by Programme Director, Louise Sherliker, were recruited to oversee a set of projects, aimed at addressing the challenges discussed within this document.

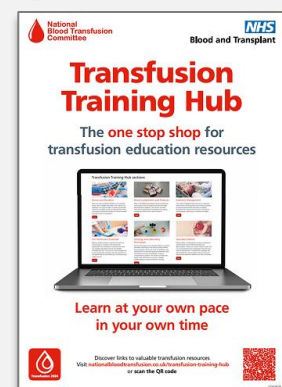
Success - What have we achieved?

Development of a professional framework for Transfusion Practitioners

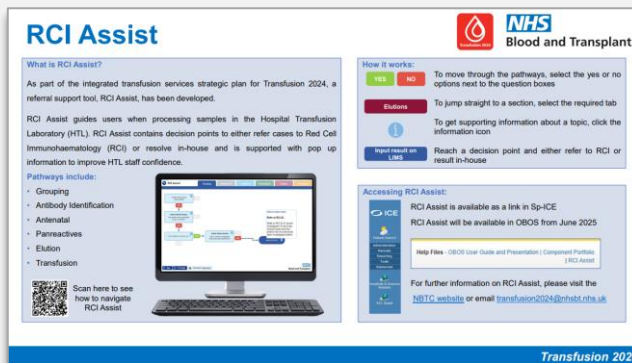
Work is well underway on the development of a Professional Development Framework to help standardise and promote the Transfusion Practitioner (TP) role. The project has secured funding to engage an experienced framework consultant. The framework is being developed *for* TPs, *by* TPs. In Spring 2025, the group hosted four webinars, which were attended by 49% of the TP workforce- highlighting strong engagement across the community. Thanks to this continued involvement and support, the framework remains on track for publication in Spring 2026.



Development of free educational support tools



Development and roll out of the **free online education resource - The Transfusion Training Hub**
Over 32,000 views in its first year!



Development, roll out and provision of training for **RCI Assist** – a free referral support tool for laboratory staff.

Education surveys / data gathering to assess knowledge gaps in the workforce

Knowledge gap assessment for hospital laboratory staff.

158 responses. New bitesize education pieces to be developed

GMC approved survey circulated by the Education Leadership Advisory Group for Education, to identify knowledge gaps in medical staff. Data being analysed

Review of transfusion content for undergraduate Biomedical Science degree. Working group established (Uni lecturers and IBMS) to develop content

Evaluation of knowledge and skills within practitioners relating to informed transfusion consent for patients and development of support resources



Electronic requesting for NHSBT reference tests



Successful role out of electronic requesting for Fetal *RHD* testing.

40 hospitals now onboard!

Hospital data integration project



Facilitation of automated, electronic collection of component and patient datasets from the hospital LIMS, which will link to NHSBT data, to enhance visibility of all components issued.

12 hospitals enrolled for proof of concept so far with continuing engagement into 2025



Further Research and Innovation

A survey has been performed to determine current research activity in hospitals, data analysis is underway. Work is ongoing with the PROPHECY-2 trial, with site visits to help understand the barriers to becoming a research site and offering methods to encourage staff participation. Collaboration with the PROPHECY-2 team and health economists is also ongoing, and a paper is due to be written. Watch this space....👀
